

## DEDICATION The 2024 Elmore Town Report is dedicated to Jon Gailmor





The 2025 Elmore Town Report is enthusiastically dedicated to Jon Gailmor. Jon has recently moved to New Orleans to be close to family for cancer treatment but will remain forever in the hearts of Elmore residents.

Jon grew up in the Philadelphia area, later moving to Connecticut where he began singing in school choral groups. He attended Penn State and Temple University and graduated with a degree in Education. After spending 7 months traveling throughout Europe, Jon discovered that singing and performing were his true passions. He released a record with a partner under a major recording studio, but decided that this was not the path he wanted to pursue. Jon migrated to central Vermont in 1977, later settling in Elmore with his wife, Cathy and raising a family here. In Vermont, Jon sang and performed in local venues but discovered his true passion singing for children and helping them write their own songs.

Jon became our very own local celebrity performing all over the United States while releasing five albums filled with songs he wrote. For almost 25 years, Jon hosted a radio program called "Just Kidding," visiting children in schools all over the state and giving his listeners an opportunity to appreciate the unique perspectives of our youngest residents. "Just Kidding" reminded his audience not to take themselves too seriously. Jon was also a popular participant in the Vermont Council on the Arts (now Vermont Arts Council) Artist-in-Residence program and worked with children in schools all over the state to create their own songs. One of his songs, "Hal of Hardwood," was written specifically for the Elmore School when they were studying medieval times. Jon came to

school dressed as a medieval minstrel (wearing green tights) sharing stories from his travels around the region. Jon volunteered a lot of time at the Elmore School and supported the students in writing an Elmore School Song many times between 1993 and 2024. Most likely any Elmore School graduate or parent from the past 30 years can sing snippets of their own song! Jon loves the Elmore School and was a strong advocate for the special community created within its walls.

For as long as he has been in Elmore, Jon has devoted much of himself to his community, helping people realize how important they each are. Jon always ensured that whomever he interacted with felt noticed and appreciated and he generously shared his musical talents for free to help others. Jon has served on the board of Lamoille County United Way for 20 years, volunteered for Habitat for Humanity, was an ardent local youth soccer fan, a substitute teacher for all ages in Lamoille South Supervisory Union, and has been Elmore's Town Moderator since 2010. Jon conducted our meetings with his trademark sense of humor and with a great deal of respect for our town. He has remarked that serving as our Town Moderator has been one of the great honors of his life and we could not be more grateful for all that he has given us.

ARTICLE 2: To elect the following officers:

ARTICLE 3: To elect School Directors of the Elmore-Morristown Unified Union School District:

a. One for a term of three (3) years - Morristown resident

b. One for a term of three (3) years - Elmore resident

ARTICLE 4: Shall the voters of the Elmore-Morristown Unified Union School District authorize the School

Directors to apply five hundred thousand dollars (\$500,000) of the school district's fund

balance as revenue for the 2025-2026 school year budget?

ARTICLE 5: Shall the voters of the school district approve the school board to expend \$18,467,678, which

is the amount the school board has determined to be necessary for the ensuing fiscal year? The Elmore-Morristown Unified Union School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$12,179, which is 8.71% higher than

per pupil education spending for the current year.

BUILDING AND SEPTIC PERMITS: A permit is required from the Zoning Administrator (Charles Burnham) before any building or structure is erected, enlarged, relocated or changed in use in any district, and also for any land development and subdivision (except agriculture or forestry). A permit is required from the State Environmental Dept. before any sewage disposal system is built, altered or repaired. **DOG LICENSES**: Pursuant to 20 V.S.A. 3581, a person who owns, harbors, or keeps a dog more than four months shall annually, on or before April 1, cause it to be registered.

#### **MOBILE HOMES:**

As required in 32 V.S.A. Sec. 5079, an owner of a mobile home shall register the home with the clerk in the municipality in which it is located by providing a bill of sale or true copy thereof. The clerk shall maintain a public record of mobile home registrations and shall charge a fee of \$15.00 for each registration.

#### Elmore Select Board - Annual Report - 2024

#### Calendar Year 2024 Highlights

- Town Operations: Spending and operating budget achieved 95.8% predictability (Actual vs. Budget). Continued fiscal responsibility ensured stable municipal spending and well-funded reserve accounts for equipment purchases and general town needs.
- **Highway Maintenance Facility:** Successfully moved into the new Highway Maintenance Facility in January 2024. Final project costs were within 1% of the planned budget.
- Town Tech Upgrades: Implemented upgrades to town communication platforms, including enhanced broadband connectivity through Lamoille FiberNet's expansion to Elmore. This ensures high-speed internet access to town offices and facilities, improving operational efficiency.
- **Zoning and Resources:** Appointed Charlie Burnham as the new Zoning Administrator. Nick Morales continues to serve as Webmaster. Additional town staffing remains fully operational, with no open positions.
- Emergency Response and Preparedness: Expanded the Local Emergency Operations Plan and updated FEMA Emergency Shelter protocols. Additional funding secured to support these initiatives.
- **Community Engagement:** Supported the 5th annual Elmore 5k race and the community fireworks display. Collaborated with the Lake Elmore Association to continue funding for the milfoil control and greeter programs.
- Water System: The water system operated successfully within budget while exceeding quality standards. Funding rates and reserves remain stable, ensuring consistent service.
- Road Maintenance and Erosion Control: Updated the 5-year Road Erosion Plan to meet State-mandated drainage and erosion control standards. Continued to address the financial impact of these mandates through proactive budgeting and pursuit of grant funding. Began installation of Runoff mitigation at Lake Elmore.
- **Grants and Funding:** Secured a flood mitigation grant for the buyout of an additional flood-prone property. The reclaimed land will be maintained as open space.
- Town Hall | Fire Code: Launched plan to bring TH into fire code compliance with Fire Marshal and ADA. Completing in 2025.
- Selectboard Actions: Responded to a range of town concerns, including roadway maintenance, zoning, and citizen feedback on town operations. Resolved 61 of 63 specific items brought before the board, achieving a 97% resolution rate for the year.
- Town Meeting Day v Australian Ballot: Held public input sessions on question of moving to Australian ballot similar to other VT towns. Town voted to continue Town Meeting structure, date and start time.
- Town Legal Services: Conducted extensive search and retained Monaghan Safar as the Town's new legal services firm.
- FEMA Reimbursements: Continue to work with FEMA to receive reimbursement for the June and July 2024 floods.
- Selectboard Meetings: Held 22 sessions throughout the year to efficiently address town business. Meetings continue to include hybrid options for accessibility.

#### 2024 – 2025 Continuing Programs/Issues

- Bridge and Road Projects: Ongoing construction for the VT Route 12 Corridor Project, including Elmore Bridges 90 and 94. Traffic disruptions anticipated, with completion scheduled for 2025. These projects are 100% state and federally funded.
- Erosion Control Costs: Continued management of costs associated with State-mandated erosion control measures under the MRGP (Municipal Roads General Permit). Evaluating new strategies to mitigate financial impacts.
- **Town Infrastructure:** Evaluating the need for additional staffing for the road crew and considering replacement of aging town equipment, including a dump truck and loader, to maintain high levels of service.
- **Community Growth & Communication:** Continuing to enhance community events and programs, fostering engagement and participation from residents. Launched new Town Blog on website launched new communication calendar.

#### 2025 - 2026 Future Plans

- **Road Crew Staffing:** Conducting a comprehensive review of staffing needs and resources to address increasing demands on the highway department.
- **Equipment Purchases:** Anticipating the purchase of a new truck and evaluating the replacement of other key equipment to maintain operational efficiency. Contributions to reserve funds not keeping pace with expected 10-year purchase forecast.
- **Broadband Optimization:** Assessing the impact of high-speed internet expansion on town operations and identifying further opportunities for technological advancements to aid in communication and participation.
- **Grant Opportunities:** Proactively pursuing state and federal grants to support ongoing infrastructure projects and community initiatives.

2024 Was a relatively typical year for the Elmore Fire Department. In addition to the fire calls and car accident scenes there were a number of mountain rescue calls on Elmore Mountain. The flooding this year also prompted a number of call responses and prompted the department to review flood response scenarios.

EFD members took part in a number of community events that supported the fire department as well as other community organizations. The Chicken BBQ and Harvest Supper fundraisers were very successful this year and well attended. Members provided traffic control for the Annual Labor Day Celebration 5k run and Gravel Grinder Bike Ride. Several members also provided support for the Elmore Mountain 5k Run.

We are always looking for outside funding sources to supplement the funding we receive from the Town each year. Thanks to the diligent work of firefighter Don Zukswert, the department was awarded 4 free sets of bunker gear through a sweepstakes program this fall. The total cost of this gear is over \$10,000.

Several properties in Elmore have installed a Knox Box. These boxes allow the fire department to access your building in the event of an emergency without causing damage to the doors or windows. To learn more about the program, visit our website: elmorefire.org.

The Elmore Fire Department also installed a number of free smoke and CO detectors this year. Through the Fire Safe 802 program. If your home is in need of smoke or CO detectors, please reach out to us about installing free detectors. Functioning smoke detectors are the best way to protect your family and property from fire. If you don't already have functional fire extinguishers in your home, please consider investing in them. Fire extinguishers are a critical "first line of defence" when a fire does break out. Fire extinguishers typically last 10-12 years, check the label or gauge to be sure.

We have several new, very active members of the fire department this year. We are glad to have some new, young faces taking part in weekly training and responding to calls. Even with this fresh squad of firefighters, we could always use more hands. TOWN WIDE REAPPRAISAL: As most of you are aware of, we have started the reappraisal for Elmore. We have hired NEMRC to complete the reappraisal for the Grandlist of 2025. All of Elmore properties should have had a visit from the NEMRC people to collect data on their properties for this 2025 reappraisal. The time line for property owners for the informational hearings is scheduled for April 30th and May 1st. (times to be determined.) Also, the formal grievance hearings are scheduled for May 19th and May 20th, (times to be determined.) Please remember when talking about new values, you are grieving your assessed value, not your property taxes. Sometimes that is hard to separate . Please visit the Town of Elmore web site for more information as it happens. If anyone has any questions before any of the scheduled meetings, please contact the Town office at 802-888-2637 or e-mail the Listers at <a href="mailto:listelmore@gmail.com">listelmore@gmail.com</a>. At this time we only have collected buildings and land information. We do not have values set yet.

The State of Vermont has now passed a town wide reappraisal every six years. So the reappraisals will be happening on a six year schedule instead of what you all are used to, every ten to twelve years, unless you had improvements or changes.

This last year Elmore's property sales were almost all substantially above our listed values. Our CLA (current level of appraisal) was 59.05%. It should be right around 100%!

The Town of Elmore is also looking for two more Listers. Part time, paid position. Please stop by the Town Office for info and an application if you are interested.

#### **Road Commissioner Report**

**2024**, what a year it has been! The long awaited new facility was put into use in February. The work space is a joy to work in. The garage will serve the Town well for many generations to come. Over 200 people attended our open house event on Green up Day.

Everyone's favorite time of the year, mud season, came every month. We graded roads and used over 2000 yards of material in trying to keep the roads as good as possible.

Summer rains did not pass us by. In June, the area of Bedell Brook Rd., Mowry Rd. and Earl Gray Rd. were damaged. All was repaired just to have another flooding event on July 11, on the anniversary of the 2023 flood, and destroyed us again. With our crew and the help of M.S.I., most roads were open to a minimum of one lane in 48 hrs. I wish to thank everyone for their patience while this was happening. Preliminary estimates of damages were at a million dollars plus. Due to the unavailability of contractors and scheduling, I made the decision of renting a large excavator and doing the work ourselves. Yes, this may have meant taking a little longer getting the work completed, but the benefits were. #1 Work is done. #2 Less out of pocket cost, and #3 Easier to meet FEMA's criteria. Total of the damages is going to fall in around the \$300,000 mark.

The Highway Department wishes to thank its employees, Claude Cross, service providers, and friends and neighbors that helped us along the way.

The Zoning Office administers the Elmore Zoning Bylaws to protect property and people and to ensure the quality and safety of development.

It was my privilege to be appointed Zoning Administrator in February 2024. Since then, I have updated the Zoning Permit Index and updated the Issued Permits listings to include Parcel ID #s; instituted a more formal written DRB Findings and Decisions format; instituted a checklist for applications to insure all required notices and Warnings are accomplished in a timely manner; revised and improved Application forms to be more user friendly; revised and updated the Application fee schedule; and followed up on permit conditions and compliance verification. I offer continued guidance to the Planning Commission and Development Review Board as needed. I keep the Selectboard informed of Zoning Office matters at their monthly meetings. Most all the above is posted on the Town Web Site: <a href="www.elmorevt.org">www.elmorevt.org</a>. I hold office hours three days a week 9 to 3 to meet and greet and help landowners with zoning and development concerns.

Elmore is one of only three towns in Vermont that is approved to administer its own Shoreland Zoning around Lake Elmore. The review and application process mirrors State regulations but is administered locally to be more responsive to landowners while maintaining sensitivity to shoreland protections. As a VT Licensed Landscape Architect, I have been able to guide landowners with lakeside tree removal, pruning and replacement while complying with Vegetation Protection Standards.

I welcome your e-mails, calls and visits and value the opportunity to help property owners learn how they can build and develop in compliance with the Elmore Bylaws.

A big thanks to all the residents who have helped make my job an enjoyable one.

#### **LAKE ELMORE ASSOCIATION REPORT (2024)**

Control of EWM (Eurasian Water Milfoil) has been undertaken in Lake Elmore since 1981. Continued control will be necessary to ensure that dense infestations do not occupy an increasing area of the Lake. By controlling the EWM, the project helps to ensure that swimmers, boaters and fishermen will be able to continue to have access to the lake. Without action, in the very near future, access to the lake via the State Boat Ramp and State Park Beach will become impossible.

This year, AE Commercial Diving services performed a five-day visual inspection of the entire lake to identify areas of EWM infestation. AE Commercial Diving Services Inc. reported two distinct intensities of infestation The north, east and west areas of the lake showed sporadic growth and required mainly hand pulling. The South end of the lake showed moderate growth, which required diver assisted suction harvesting.

The areas with sporadic growth required hand-pulling of the EWM, which began on July 6, 2024. Unfortunately, due to flooding and visibility issues, the divers experienced poor underwater visibility, and therefore ceased hand-pulling on July 10 2024. The divers returned on August 27, 2024 and worked through September 2, 2024 to perform suction harvesting. The divers spent a total of 13 days on the lake, which was the same as last year.

The divers removed a total of 325 gal of milfoil vs 164 gal last year. That is an increase of almost 100%. This increase may be due to the flooding we experienced this summer. Runoff from the area farmland likely increased the amount of nutrients in the water, thereby feeding the EWM. The entire perimeter of the lake was attended to by the divers. This includes the Fish and Wildlife access and the State swimming area. Unfortunately, we cannot control mother nature, and the diving crew did the best they could under the circumstances. We hope this increase in EWM is just temporary and that our efforts will continue to help to mitigate the amount of milfoil in the lake. The EWM that was removed was composted and used by local gardeners.

The seventh year of our greeter program continued to be a great success. We had 3 greeters return from last year and we hired one new greeter. We continued to monitor the lake (3) three days per week, 12 hours per day (8:00am – 8:00pm). The program was open on weekends (Friday through Sunday) and holidays throughout the summer season. The greeter program began on May 31, 2024 and ended on September 7, 2024. During this period a total of 861 inspections were performed. Last year 714 boats were inspected so our inspection numbers increased by 20.5% this year. As last year, a severe July rain storm led to the water level rising almost 5 feet, flooding the boat access area, and increasing high E-Coli readings at the State Park Beach that caused the lake to be closed for swimming. Plant life was found on 103 boats compared to 17 last year. This is a huge increase and is attributable to an increase in both native and invasive plant growth. As mentioned above, this increase in growth can be attributed to runoff resulting in additional nutrients going into the lake during the July storm. The greeters continued to submit to the state the inspection data, including pictures of the plant material, each day that the program ran.

With the measures implemented this year, we have restricted the spread of the EWM and decreased the size of the dense infestations. Such controls ensure that recreational use of the Lake can continue, and the ecological integrity of the Lake remains intact. To maintain these successful programs, the Lake Elmore Association requires funding from various sources. This year we received a grant of \$26,894 from the State of Vermont and \$15,000 from the Town of Elmore. Without this money, we could not have done the work that needs to be done. Although the Town of Elmore and State have contributed generously, the cost of getting the milfoil under control is increasing dramatically. The Lake Elmore Association held many successful fundraising and community activities to raise additional funding. These fund-raising efforts included 3 pancake breakfasts and weekly Bingo throughout the summer. The Lake association also provided free activities for the community including a tractor parade on Father's Day, a boat parade on the fourth of July, a floating concert in mid-July, and a pie social at the end of the summer. These activities were very popular and enjoyed by the entire community.

To continue to address this ongoing problem, continued funding will be necessary. Lake Elmore Association members have volunteered many hours at fundraising events to support the program. Community support for the program remained strong as the Lake Elmore Association continued to receive donations from the public. Since we have a 501(c) (3) status from the IRS, contributions are tax deductible.

The Lake Elmore Association would again like to thank all the voters of the Town for their support of our effort to ensure that Elmore remains the "Beauty Spot of Vermont."

#### Elmore Planning Commission Report

#### 2024 Highlights:

Change in PC membership – After many years as chair, Kate Sprague stepped down from the Planning Commission. We thank Kate for her hard work and dedication to the Town of Elmore. Dawn Angney-Kress and Bruce Olsson have agreed to serve as cochairs. Additionally, Nancy Davis and Shorty Towne have joined the Planning Commission.

New Zoning Administrator – The Commission interviewed a number of prospective candidates for Zoning Administrator and sent two recommendations to the Select Board for the final selection. Charles Burnham was then chosen to be our new Zoning Administration and is working closely with the Planning Commission on zoning questions and a revised town plan.

Elmore Town Plan - Under Vermont statute (24 V.S.A. Chapter 117), a new town plan needs to be reviewed, revised, and adopted every eight years to best reflect the current trends, needs, and desires of the community. The town plan establishes goals and priorities for our community and is also a prerequisite for many state loans, incentive programs, and grants. The current Elmore Town Plan was adopted in 2018 and is valid through 2026. The Commission is working with the Lamoille County Planning to revise the current Elmore Town Plan and this work is expected to continue through 2025. Elmore residents are encouraged to attend Planning Commission meetings and give input on the revised Elmore Town Plan.

Town Property Community Survey - To learn about how residents of Elmore might like to use the 10 acres of town-owned property near the town garage, a survey was conducted. The timeframe for any potential change to the property is dependent on Elmore resident input and securing funding (e.g., grants, fundraising). Of the 69 people who took the survey, 68% said that they think the town should use the property for community space (20% said maybe). The ideas with most favorable responses were walking trails, native plants to support wildlife, and a cell tower.

Elmore 5K Run/Walk – Despite rainy weather, 151 participants took part in the fifth annual Elmore 5K Run/Walk. There were thirty-eight kids in the Kiddie Run.

Speed Signs – Working the Lamoille County Sheriff's Department, funds were secured to purchase two speed detection signs for the town center. The signs are expected to be installed in 2025.

#### **Elmore Cemetery Commission 2024 Report**

The mission of the Elmore Cemetery Commission (ECC) is to ensure that the Elmore cemeteries receive quality care and are managed in an efficient fashion for the benefit of community members.

The Elmore Cemetery Commission is responsible for the Lake View Cemetery on Route 12 and the Elmore Mountain Road Cemetery. Only the Lake View Cemetery is available for plot sales and new burials. Green burials are currently not permitted.

The day-to-day care (e.g., mowing, trimming, marking plots for headstones) of the two Elmore cemeteries has been in the very capable hands of Keith Cochran. Keith and his family have been taking care of Elmore's cemeteries for over 40 years and we are greatly appreciative of their commitment and dedication to Elmore's cemeteries.

In the fall of 2024 the Lake View Cemetery sign, which matches the design of other town signs, was put up, thanks to the help of several town residents. Look for the new sign along Route 12.

During 2024 the ECC began the process of developing a long-range plan for the cemeteries which includes succession planning and continued cleaning and repair work for gravestones, many of which are over 100 years old.

Financial expenses in 2024 were less than budgeted with the next phase of repair work rescheduled to 2025. ECC expenses also reflect the generosity of time and effort by the Cochran family.

#### **Current Financial Status**

Over the next several years the Elmore Cemetery Commission will need to work with the Select Board on plans for accessing the Lake View Cemetery from the Town Garage property, which would provide a better and quieter way to visit the cemetery. The ECC will also be evaluating how to incorporate (e.g., fencing, burial options) the recently donated acre at Lake View with the current cemetery property.

SUBJECT: FY2024 ANNUAL OPERATING SUMMARY

#### **FINANCIAL SUMMARY:**

• FY24 is the 9th full year of sustained system operations with full debt service load.

- The FY14 & FY15 loans were structured with a 12 month grace/transition period until first payment in FY16.
- Final costs for system construction were ~\$50,000 **below initially approved budget and loans** due to early completion, aggressive Project Management and Town volume materials contracts.
  - As a result debt payments were twice renegotiated and reduced.
  - By utilizing State and Federal revolving funds, the interest rate is <3%>
     (Negative 3%) which is applied annually toward <u>reducing</u> remaining balance.
- System Operations for FY24 were within planned budget for revenues and expenses.
  - o In accordance with Service Area By-Laws, any annual surplus is applied to operating reserves for Capital, Emergencies and Unscheduled Maintenance.

#### **OPERATING SUMMARY:**

- The system operated without variance at levels exceeding all EPA and State ANR requirements for water purity, pressures, volumes and capacities throughout the year.
- The Elmore Water Service Area met all requirements of its ANR Operating Permit.
- Despite fluctuating winter, the system achieved sustained operations availability >99%.
- The water system operations plan is rated by ANR/DEC as **<u>superior</u>** for operating and financial predictability, reserves accumulation for emergencies and capital needs.
- Without the water system, no potable water exists in the town center area. The annual operating cost is \$1282/ERU yielding an operating loss of \$532/ERU which is offset by town funding thus preserving the town center, school, church and residences.

#### **CONTINUING OPERATIONS:**

- The combination of local volunteers performing required daily operations and testing coupled with required Licensed Operator, Ross Environmental Systems, for ANR approved oversight significantly reduces operating costs by over \$4500/year which reduces subscriber rates by ~\$250 per ERU (Equivalent Residential Unit). Be sure to thank Jon Osborne and Nancy Davis who perform daily and event testing, monitoring, sampling, performance monitoring and troubleshooting.
- More volunteers are needed. Any Town Resident is eligible. Please consider volunteering. Without the water system our village center, school, store, Town Office cannot exist due to ANR, DEC and EPA water quality regulations.

#### **FY2025 PLANS:**

- Subscriber rate remain @\$750/ERU
- Flush system hydrants. Conduct & verify lead pipe inventory (ANR requirement) .
- FY25 Town contribution remains \$9000/year, preserving town center.

ECT thanks all the volunteers who took the time to join us and pitch in.

This year's Annual Gravel Grinder ride saw 100 riders traverse 47 miles through the towns of Elmore, Hyde Park, Wolcott, Hardwick and Craftsbury. Some challenging conditions and terrain awaited but riders were rewarded with a delicious post-ride meal served by volunteers and ECT board members. Folks had time to eat, clean up and move just down the street to the Town Hall for live music from Michael Perry, Leslie Grant and the Eames Brothers. Thanks to all the sponsors who made the day's event a success!

After sixteen months at the helm of the Elmore Store, Jason Clark notified ECT of his desire to move on to other pursuits. We thank Jason for taking on the colossal task of running a general store and for being another link in the chain that kept this essential element of Elmore's community open. We wish Jason and his family the best in whatever comes next.

As with any transitions, there are both endings and beginnings. The end of 2024 saw the dawn of a new era for the Elmore Store. Tim and Becca Lindenmyer emerged as a willing and very capable team to embrace operating the Elmore Store. Tim and Becca produced a thoughtful, compelling proposal for renovating and operating the store in 2025 and shared that vision during a community meeting in late November. Tim's mother, Jill, (a founding member of ECT) would certainly be proud to see her legacy take shape in this way.

The last week of December was unique as ECT Board members and their families along with Tim and Becca served as volunteer shopkeepers and provided answers to community questions. On the evening of December 31<sup>st,</sup> the store closed and a period of renovation began. #### In Elmore these services included:

- Providing information about VTrans grant programs and other available funds for road projects;

- Assisting with updating of Local Emergency Management Plan;
- Providing technical assistance related to options and funding sources for replacement of the Town Highway Garage;

- Providing outreach on funding opportunities for clean water projects;

- ❖ Providing technical assistance to the Lamoille Fibernet Communications Union District;
- ❖ Providing outreach and informational resources about the Municipal Energy Resilience Program.
- Provided Low Emissions Analysis Platform (LEAP) and renewable energy generation targets.
- Provided assistance with drafting an update to the Municipal Speed Ordinance.
- Provided technical assistance with reporting damage for the June 2024 storm damage.
- ❖ Participated in site visits/planning meetings and coordinated with the Lamoille County Conservation District and Fitzgerald Environmental Associates to provide input for the stormwater mitigation project by the Elmore Town Hall. LCPC provided awareness of Elmore Store new Septic system plans to ensure proposed stormwater projects would not conflict with the new septic system now installed.
- ❖ Conducted a consultation with the Elmore Planning Commission on the Municipal Plan update. The LCPC has since then began the update of the Municipal Plan.

In 2024, the Lamoille County Sheriff's Department has prominently adapted to the current pattern of offenses found throughout our communities. An increase in staffing has allowed deputies to significantly increase our directed patrols on roadways and in neighborhoods where quality of life issues and vehicle safety concerns have arisen.

Technology in global electronic communications has been rapidly evolving, which has unfortunately also brought a new form of criminal element to our rural communities, Cybercrime. Our investigations into digital and telephonic financial fraud cases has significantly increased along with the advancements in technology. Our Investigators have prevented many residents from being victimized, and losing tens of thousands of dollars during these heinous acts of fraud.

Drug trafficking from out of state urban areas is still a consistent problem in Northern Vermont. The Lamoille County Sheriff's Department works hand and hand with our partners in federal law enforcement which has resulted in many high profile arrests and seizures over the past few years. The disruption of the local illicit drug trade has resulted in a noticeably lower volume of property crimes and overdoses within our communities in 2024.

The past year has allowed for more Deputies to attend specialized training for the ability to provide more comprehensive law enforcement services. The Lamoille County Sheriff's Department strives to increase the quality of life in our communities.

# APPROPRIATIONS 2025-2026

#### **AMERICAN RED CROSS - \$250.00**

Our mission at the American Red Cross is to prevent and alleviate human suffering in the face of emergencies by mobilizing the power of volunteers and the generosity of donors. Last year our staff and volunteer workforce provided an array of services throughout the Northern New England region. We made 626 homes safer by installing 1907 smoke detectors, trained almost 39,492 people in first aid, CPR, and water safety skills, collected 131,800 units of blood and gave supportive services to over 3,400 service members in our region. We are grateful to received municipal support from our friends in Elmore. These funds will stay right here in our region.

#### **CENTRAL VERMONT ADULT BASIC EDUCATION - \$250.00**

Central Vermont Adult Basic Education, Inc. (CVABE), a community-based nonprofit organization has served the adult education and literacy needs of Elmore resident for fifty-nine years. Elmore adults and youth who are out of school seeking help with learning basic reading, writing, math and English as another language may receive that help through a free program of instruction provided by Central Vermont Adult Basic Education. Students enrolled in the program also have the opportunity to study for their high school equivalency exam (GED) or to pursue other options for gaining a diploma.

Students and teachers meet in classes, one-to-one, and/or small group sessions to complete a learning program which suits the requirements of each adult student. Individualized instruction ties together basic literacy and math skills with practical interest areas. Helping children with homework, budgeting, filling out forms and applications, learning beginning computer skills, studying for a driver's permit or a Commercial Driving License, reading work related texts, writing reports, and preparing for employment or college are just a few of the many areas which adults choose to study.

Last year, 2 residents of Elmore enrolled in CVABE's free programs, and 1 Elmore residents volunteered with CVBE.

#### CENTRAL VERMONT COUNCIL ON AGING & RSVP - \$250.00

Central Vermont Council on Aging is a nonprofit organization. There is no charge to elders and their families for services provided. The Council uses federal, state, and local funds to provide a variety of programs and services, either directly or under contract with local groups and organizations.

Among the services provided directly by or under contract with CVCOA are information and assistance; community and home delivered meals; health insurance counseling; transportation to essential destinations; family caregiver support and respite grants; mental health services; legal services; companionship; food stamp and fuel assistance outreach; and help with household tasks. In the past year, we have touched the lives of thousands of elders throughout Central Vermont. During the past year, 14 Elmore residents received one or more of the services that CVCOA provides.

#### **CLARINA HOWARD NICHOLS CENTER - \$250.00**

Founded in 1981, Clarina Howard Nichols Center works to end domestic and sexual violence in Lamoille County. Clarina provides advocacy, shelter, and support to survivors and their families as well as outreach education programs. Clarina works to affect social change within our communities through increased public awareness. Violence free tomorrow, is our vision today!

Survivor centered advocacy and outreach has always been at the heart of Clarina's work – and of the movement to end domestic and sexual violence as a whole. Clarina's programs address the critical needs of survivors and their non-offending family members. During the past year Clarina served 473 individuals, including provided shelter to 47 individuals (35 adults and 12 children's), for a total of 2,153 bed nights, responded to 1,257 hotline calls.

LAMOILLE RESTORATIVE CENTER - \$150.00

**LAMOILLE Restorative Center** empowers people to make good choices and connect positively to their community. Our mission is to address unlawful behaviors and support victims of crime, while promoting healthy families and communities with the Lamoille Valley. The number of children, youth, and adults who reside in Elmore served by one of LRC's fifteen programs in fiscal year 2024 was nine.

These interventions save tax dollars, reduce recidivism and help people address issues that often lead to crime in the first place – addiction, mental health and poverty.

## LAMOILLE COUNTY SPECIAL INVESTGATION UNIT - \$250.00 CHILD ADVOCACY CENTER

The Lamoille County special Investigation Unit is a non-profit organization dedicated to investigating, prosecuting, and providing victim advocacy services for sexual violence, child abuse, domestic violence and crimes against vulnerable adults. The LCSIU represents a continued collaborative partnership between the Lamoille County State's Attorney Office, VT State Police, Lamoille County Sheriff's Dept., Morristown and Stowe Police Dept., The Clarina Howard Nichols Center, Copley Hospital and the Dept. for Children and Families, as well as various medical and therapeutic service providers. The LCSIU/CAC is the lead organization for executing county wide sex offender registry checks, conducted once a year to ensure that known registered sex offenders are complying with the requirements of the Vermont Sex Offender Registry.

In fiscal year 2024, the LCSIU/CAC was involved in 123 incidents throughout Lamoille County, 105 investigations related to allegations of physical and sexual violence against children and 18 investigations related to allegations of abuse against adult victims. Town funds supplement our state funds and help us to support our detectives in effectively investigating incidents, our victim advocate in helping victims through this very difficult process, and the State's "Attorney's office in attaining justice.

#### LAMOILLE COMMUNITY FOOD SHARE - \$250.00

Lamoille Community Food Share is a locally funded, volunteer powered non-profit corporation. Our mission is to help support and improve the physical well-being of individuals in our service area who might otherwise go hungry for reasons beyond their control. To this end, we will provide them with food free of charge, primarily on an emergency basis. We will encourage and guide them in the selection and preparation of healthful food. Our service area consists of the Lamoille County Vermont towns of Eden, Elmore, Hyde Park, Morristown, Stowe and Wolcott. We have served nearly 7,000 people and average 500 families per month. In the month of October 2024 there were 20 visits from 15 different families from Elmore, serving a total of 49 individuals. The support we receive from our community allows us to keep our doors open 6 mornings a week for those in need. More than ever, we appreciate the help we have received in the past and look forward to continued support from our friends and neighbors in Elmore. Your support of LCFS ensures that the citizens of Elmore have access to healthy nutritious food. Thank you!

Lamoille Economic Development Corp. serves as a point of contact for municipalities seeking addition information on economic development activities, local business projects, funding opportunities, legislative action and more. Our services are available to all business in all commercial sectors whether they are existing businesses looking to expand, start-ups or businesses seeking to relocate to Lamoille County. Strengthening the county's economy by helping facilitate the creation, retention and expansion of jobs and businesses and investing in the prosperity of Lamoille County communities are cornerstones to all LECD efforts. #### LAMOILLE HOUSING PARTNERSHIP - \$150.00

The Lamoille Family Center is in its 47 year of service to children, youth and families by the Lamoille Family Center! During this time, thousands of individuals throughout the Lamoille Valley have received our services, including home visiting, parent education, playgroups, child-care resource and referral, youth services, and emergency assistance. Countless children are stronger, safer and more confident as a result of their involvement with the Family Center. In fiscal year 2024, more than 4,000 children, youth, parents and caregivers throughout the Lamoille Valley received home visits, participated in playgroups, attended parent education classes, received Reach Up services and engaged in monitored parent-child contact. Hundreds more families and child care providers received child care support services including assistance with applying for Child Care Financial Assistance, referral to regulated programs, professional development or child care staff, and participation in the Child and Adult Care Food Program.

Support through volunteer time, donation of goods and services and financial contribution remain vital to the sustainability of the Lamoille Family Center. We could not do this work without you. We invite you to stop by for a visit, meet some of our staff, and see a glimpse of what happens each day at the Family Center.

#### LAMOILLE HOME HEALTH HOSPICE - \$250.00

We are a non-profit visiting nurse organization providing home health and hospice care to people of all ages in our communities. Our office is located in Morrisville, but we make visits to all ten Lamoille county towns. Visits are made at all times of the day and night depending on the needs of the patient. Our mission is to support health, independence and dignity through quality care in the home.

Lamoille Home Health & Hospices in its 53<sup>rd</sup> year of providing care. As we look back, it is town support that has remained the dependable constant. Area residents give us the energy to forge ahead, whatever the circumstances in the health care industry, in federal legislation or in state government. 365 days of the year LHH&H provides home care to anyone in Lamoille County who qualifies and who needs us – regardless of their ability to pay. Our population is aging. Lamoille County is poised to expand its population of people over the age of 65 by as many as 5000 additional seniors by the year 2030.

Last fiscal year, LHH&H staff made 256 home visits to residents of Elmore.

#### MEALS ON WHEELS OF LAMOILLE COUNTY - \$250.00

Meals on Wheels of Lamoille County, provides home delivered meals to seniors and individuals with disabilities throughout Lamoille County. Our meals provide recipients with 1/3 of their daily nutritional requirements. In addition to a meal, our program provides a daily check-in by volunteers and staff who deliver the meals. Often times the meal delivery person is the only individual that our recipients will see in a day. This has led to volunteers and staff assisting in emergency situations. We are also able to make referrals to other needed services. Our services help our recipients to remain in their own homes and communities for as long as possible. Meals on Wheels have 2 meal sites throughout the county that provide a welcoming social environment for seniors to enjoy a nutritious meal together. In fiscal year 2024 ending on September 30, 2024 we prepared 57,629 meals, including the daily deliveries to the 3 residents of Elmore

#### **RIVER ARTS - \$250.00**

The River Arts serves over 5,000 people all across Lamoille Valley including the good people of Elmore. In 2024, Twenty-five Elmore residents enrolled in our classes/programs, and many more have come to our free community events. River Arts brings vibrancy to our community through the opportunity to participate in Art. It enriches our community and makes this a better place to live!

#### **RURAL COMMUNITY TRANSPORTATION - \$250.00**

Rural community Transportation, Inc. is a private nonprofit 501 C3 corporation which has provided public transportation services throughout Caledonia, Orleans, and Essex Counties since 1991, and now serves Lamoille County. RCT operates fare-free shuttle and commuter bus routes, allowing connection between in our region and the ability to travel throughout Vermont and beyond. RCT also provides demand-response transportation services under several program, such as Medicaid, the Elderly and Disabled program, and rides 2 Wellness.

#### **SALVATION FARMS, INC - \$250.00**

Salvation farms is a federally recognized non-profit with a mission to build increased resilience in Vermont's food system through agricultural surplus management. Since 2005, Salvation Farms has been connecting communities with local farms and engaging volunteers to collect and distribute crops that would otherwise never make it off our Vermont farms. One of the organization's efforts is gleaning, the collection of surplus produce from farms with the help of volunteers, who then help distribute the gleaned produce to community food programs that feed many of our more vulnerable neighbors. We also process local farms surplus produce into frozen food for distribution to senior meal programs and schools. Salvation Farms is an organization that is deeply rooted in serving the communities of the Lamoille Valley. Any financial support received is critical to our ability to distribute produce from local farms to the region's residents, ensuring that Vermont moves towards a more localized, resilient food system.

#### **VERMONT CENTER FOR INDEPENDENT LIVING - \$150.00**

For the last 44 years, The Vermont Center for Independent Living has been teaching people with disabilities and the deaf how to gain more control over their lives and how to access tools and services to live more independently. VCIL employees (85% of whom have a disability) conduct public education, outreach, individual advocacy and systems change advocacy to help promote the full inclusion of people with disabilities into community life. 3 residents of Elmore received services.

#### **VERMONT FAMILY NETWORK - \$150.00**

The mission of Vermont Family Network is to empower and support all Vermont children, youth, and families, especially those with disabilities or special health needs. Formed in 2008 when two organizations, the Vermont Parent Information Center and Parent to Parent of Vermont, merged, VFN have collectively served the families across Vermont for more than 30 years. Vermont children, youth, and families are provided with a "one-stop-shop to help them reach their full potential. VFN gives a strong start, lifts family voices, and advances inclusive communities. Last school year 7,800 school children and adults benefitted from these educational programs and workshops.

### ELMORE TOWN MEETING MINUTES MARCH 5, 2024

**9:00 A.M.** Town Meeting was called to order by Jon Gailmor. The Pledge of Allegiance was led by the Elmore Community. There was a moment of silence for members of the community who have passed away during the year. Thanks were given to the Elmore Store for the coffee and Elmore Community Trust for the Donuts that they provided for Town Meeting. Thanks were given to the Elmore Road Crew for taking such good care of the roads. Thanks were given to Kent Shaw for his many years serving as our webmaster and Ken Haggett for his years as our Animal Control Officer. A warm welcome to our new Webmaster Nick Morales and Zoning Administrator Charles Burnham. Town Meeting Civil Invocation and Robert's Rules were read by Jon Gailmor. The reading of the Town Meeting Warning was waived, and Jon gave a brief review of the protocol for Town Meeting.

**Art. 1: Moderator**: Jon Gailmor nominated; passed by voice vote.

Art 2: To Elect all Town Officers as required by Law.

Selectperson 3 years: Glenn Schwartz nominated; passed by voice vote

**Lister 3 years:** Seth Hayden nominated; passed by voice vote. **Auditor 3 years:** Diane Cote nominated; passed by voice vote.

**Constable:** Eddie Adams nominated; passed by voice vote.

Trustee of Public Funds: Sharon Draper nominated; passed by voice vote.

Cemetery Commission 5 year: Dawn Agney nominated; passed by voice vote.

Cemetery Commission 3 years: Kathy Miller nominated; passed by voice vote.

Cemetery Commission 2 years: John Fish nominated; passed by paper vote.

**Art. 3:** Motion made and seconded to accept the Report of the Town District Officers. A discussion followed that the new town garage was under budget and that all local contractors were hired. The new Town Garage will be having an open house on May 4, 2024. Sharon Draper made a correction on page 15 that the estimated Homestead Education tax rate changed from 1.948 down to 1.828. Article passed by voice vote.

Vermont House Representatives Avram Patt and Saudia Lamont dropped in to answer questions and speak about current issues this year in the legislature.

**Art. 4:** Motion made and seconded to accept the list of appropriations as written. Julie Bomengen stood up and requested that the Lamoille County Food Share appropriation be increased from \$250 to the requested amount of \$750. A motion was made and seconded to approve the amount of \$750. A discussion followed and a request was made to put more information in the Town Report such as the actual amount of money that was requested and the addresses of the organizations so people who want to made donations know where to send them. Article was passed by voice vote with the increase of \$500 to the Lamoille County Food Share.

- Art. 5: Motion made and seconded to approve the article on the budget as written. Shelia Rysz and Kathy Miller spoke in behalf of the Morristown Library and requested to give them their full requested amount of \$3,000. A motion was made and seconded to approve the request. A motion was made and seconded to approve a budget of \$1,094,553.41, which includes the increase of \$500 to Lamoille County Food Share and the increase of \$2,000 to the Morristown Library, to meet the expenses and liabilities of the Town for the Fiscal Year 2024-2025 and to authorize the Selectboard to set a tax rate sufficient to provide the same. Article passed by voice vote.
- **Art. 6:** Motion made and seconded to raise money equal to those expenditures approved in Art. #5 on its Grand List for the fiscal year 2024-2025 and to pay debts and current expenditures of the Town, and if so, provide the time (Sept, 18<sup>th</sup> 2024 and March 18<sup>th</sup>, 2025) and manner in which the same will be payable? Article passed by voice vote.
- **Art. 7:** Motion made and seconded to adopt the following Declaration of Inclusion. The Town of Elmore, Vermont condemns racism and welcomes all persons regardless of race, color, religion, national origin, sex, sexual orientation, gender identity or expression, age or disability and wants everyone to feel safe and welcome in our community. As a town, we formally condemn discrimination in all its forms, commit to fair and equal treatment of everyone in our community, and will strive to ensure all our actions, policies and operating procedures reflect this commitment. The Town of Elmore, VT is and will continue to be a place where individuals can live freely and express their opinions. Article passed by voice vote.
- **Art. 8** Motion made and seconded to apply any surplus from the current fiscal year to reduce taxes in the next fiscal year 2024-2025. Article passed by voice vote.
- **Art. 9:** Will the Town vote to change the date and time of the Annual Town Meeting for 2025 to either the first, second or third day preceding the first Tuesday in March at such time it elects, pursuant to 17 V.S.A. § 2640(b), § 2655?

Warren West presented a slide show with statistics on Town Meeting participation and voting. A discussion followed regarding the pros and cons of changing the date and time of Town Meeting. A motion was made and seconded to hold the 2025 Annual Meeting on the Saturday proceeding the first Tuesday in March. A second motion was made and seconded to hold Town Meeting on the traditional First Tuesday of March at 9:00 a.m. A voice vote was taken and was passed to hold the 2025 on the first Tuesday of March at 9:00 a.m.

**Art. 10**: To Transact any other business that may legally come before said meeting. Being no further discussion a motion was made and seconded to adjourn the meeting. Motion passed by voice vote. Meeting adjourned at 1:15 p.m.
